ACCOUNT SET-UP: An account set-up fee of \$25.00 may be applied to your first order. To avoid this fee, simply place an opening order of at least \$250.00.

PAYMENT TERMS: All orders must be prepaid. For your convenience we accept Visa, MasterCard, Discover and PayPal, as well as Checks and Money Orders. Please note: Orders paid by check will be held until funds have cleared. Returned checks will incur a \$30.00 fee.

LOSS OR DAMAGE: It is your responsibility to unpack and check your shipment promptly upon receipt. If damages are discovered, notify the delivery agent at once. No claims for defects will be accepted after 14 days from delivery.

SHORTAGES: Claims for shortages must be reported to this office within 7 days of delivery.

RETURNS: We cannot accept merchandise for return without an authorization number. Contact our office within 7 days of delivery for return authorization. No claims for defects will be accepted after 14 days from delivery. Titan WebStores, LLC is not responsible for return shipping charges.

MINIMUMS: Minimum order is \$10.00 (excluding shipping & handling) for Drop Shipments and \$100.00 (excluding shipping and handling) for Wholesale Shipments.

BACK ORDERS: All orders will be held until they can be shipped complete.

RESTOCKING FEE: 15% for resalable merchandise only. No returns after 14 days. No guaranteed sales.

SALES TAX: Titan WebStores, LLC charges sales tax for all Drop Shipments within the State of Florida at a rate of 6.5%. Any applicable sales tax for Wholesale Orders, or Drop Shipments to other States, is the responsibility of the purchaser.

SHIPPING: Shipping and handling fees will be added to each order. Orders will be shipped by Titan WebStores, LLC's preferred method (USPS, UPS, or Fed Ex). Wholesale Orders will only be shipped to the "Designated Wholesale Address" indicated above.
